## Terms of agreement

### Validity

The agreement is valid for both groups and FITs (individual guests) and will be used by ZONISTA GmbH - Destination Travel Experts | Goethestr. 36 | D-50858 Köln.

### Groups

The group minimum is 15 persons, arriving and leaving the hotel together. Groups should be billed on one invoice.

### Free place policy

1 person free per 15 paying guest, 2 persons free per 30 paying guests, 3 persons free per 45 paying guests. Free places are in single rooms and on the same terms as the rest of the group or guests of a serial tour. Maximum 3 free places per date. The free place policy is also valid for groups having only meals at the hotel.

### Cancellation

Cancellation of groups can be made without charge according to the following:

100%:	28 days prior to arrival
60 %:	27-21 days prior to arrival
40 %:	20-15 days prior to arrival
30 %:	14 days prior to arrival

ZONISTA must be able to adjust the number of participants by 10% within 3 days prior to arrival.

Cancellation of FIT's without allotments can be made without charge at the latest by 12:00 pm (local time) on the day of arrival. Cancellation of FIT's with allotments can be made without charge at latest 14 days prior to arrival.

### Allotments, Bookings and Release

ZONISTA allotments should be released automatically 28 days before arrival, should Zonista not send a rooming list. Rooming lists will be send 4 weeks prior to arrival and a final check 1 week prior to arrival, but changes could appear until 24 hours prior to arrival without charge.

Bookings on request will turn automatically into a confirmation if there is no response within 24 hours.

### Overbooking

In case where the supplier is overbooked and this requires moving of the group/client to another supplier, Zonista must be informed in written form before arrival and supplier shall take full responsibility for the extra costs that possibly will arise.

### Payment

Invoices are to be paid within 21 days of receipt. Payment against voucher. Our clients will have a voucher from ZONISTA or other B2B-partner, issued on your name. You will send us the original voucher together with the rooming list or voucher and the invoice after the clients have arrived, and ZONISTA will then pay the outstanding amount. ZONISTA is only to be invoiced for services reserved by us. All extra services such as mini-bar, pay-TV, telephone, etc. are to be paid on the spot.
